

1 No means other than the sealing and redaction proposed by Apple Inc. will protect the
2 confidential business information in the GTA, the protection of which outweighs the public right
3 of access to court records.

4 Apple Inc.'s Motion to Seal is therefore GRANTED. Exhibit A and the portion of its Mo-
5 tion to Dismiss quoting the contents of that exhibit previously filed under seal shall be maintained
6 under seal.
