STIPULATION REGARDING ALTERNATIVE DISPUTE RESOLUTION

Pursuant to this Court's Case Management Order (Dkt. 64), Plaintiff United States of America and Defendant Reily Street Associates, Inc. (collectively the "Parties") hereby submit their preferences regarding Alternative Dispute Resolution as follows:

- 2. The form of the proposed ADR session is mediation, with the costs to be shared evenly by the Parties (50% by the United States and 50% by Reily Street Associates).



- 3. The Parties plan to conduct the mediation on December 17, 18, or 20, 2019, following exchange of case-in-chief appraisal reports and any rebuttal reports. Mr. Lehman has confirmed that he is available to mediate the case on these days. In the event the date of the mediation needs to be changed, the Parties promptly will alert the Court.
- 4. Counsel for the United States and a representative of the General Services Administration will attend the mediation on behalf of the government. Counsel for Reily Street Associates and two of its principals, John Brinjac and David Brinjac, will attend the mediation on behalf of Reily Street Associates.

WHEREFORE, the Parties respectfully request that the Court approve the Parties' preferences regarding Alternative Dispute Resolution.
